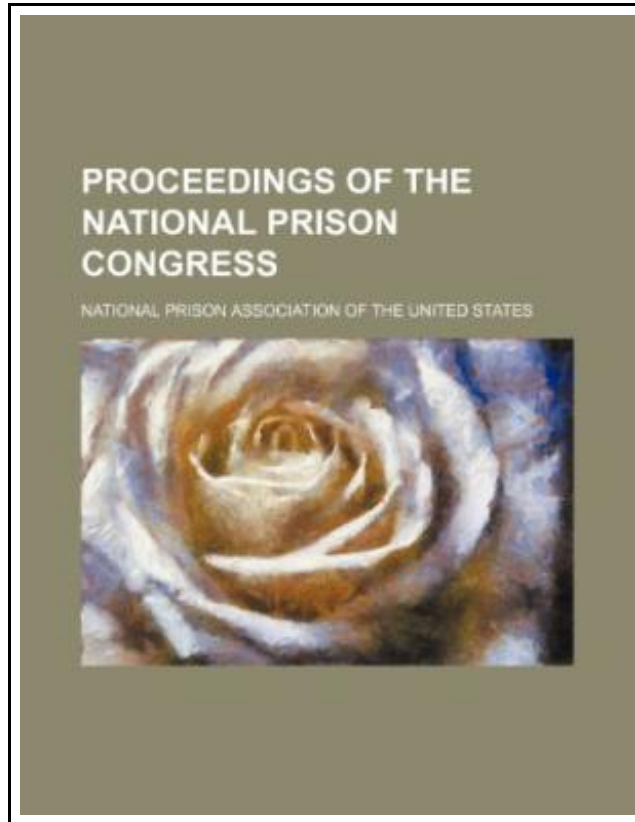

Excerpt: . . . subdivisions or committees of the legislature, and historically the jurisdiction of courts is a delegated jurisdiction. But the legislature has also acquired a right which it has not surrendered; namely, the right to determine what shall be the penalties visited upon offenders for specific crimes--a right which it exercises whenever it frames a criminal code. Now these three--the definition of crimes, the identification of criminals, and the application and enforcement of penalties--constitute all that is included under the general term, criminal jurisprudence. The theory of the pardoning power is simply this: that courts may err in the application of legal penalties to individuals, for want of evidence not forthcoming at the time of trial, or for other reasons, either by mistaking an innocent for a guilty person, or by imposing penalties disproportionate to guilt, and therefore excessive: and, in that event, the power to correct such error must be lodged somewhere. It is in fact usually lodged in the executive, for convenience sake, and because it is the special function of the executive to enforce the law. But it is not necessarily vested in this branch of the government, nor is it always lodged there. The constitution might empower courts to correct their own errors; or it might allow legislatures to correct them by special statutes in individual cases. Where the jurisdiction of the legislature over crimes and criminals is not expressly limited by the constitution, it is unlimited. And the grant to the...
