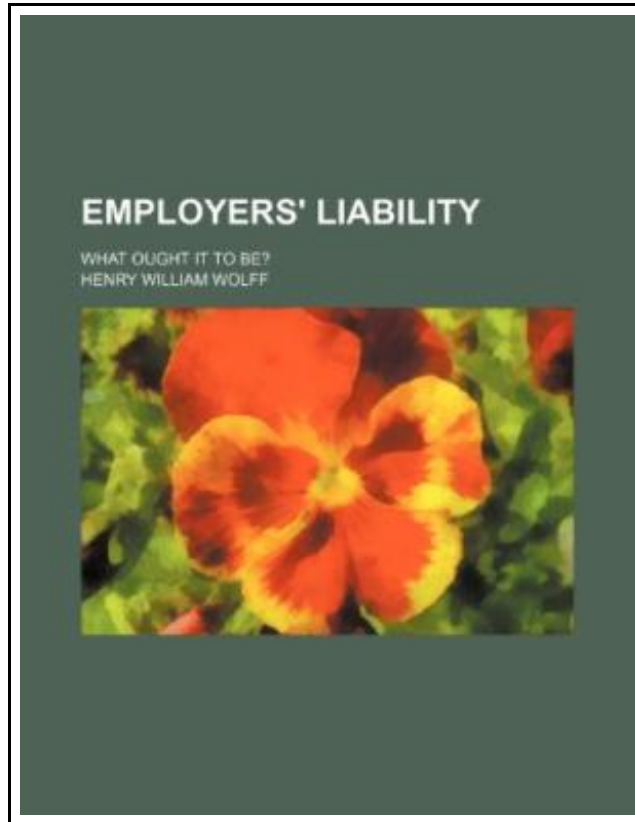

It leaves everything to the employers themselves, who have to pay, and to the elected tribunals which have to make the awards. It is therefore palpable nonsense to talk of this measure as one of State insurance. The State contributes nothing but the compelling power. In the Decalogue officially laid down the first commandment is, that the employer shall be liable for every injury that occurs to hands in connection with employment. There is no question raised of negligence, no necessity imposed of proof. The accident proves itself. German employers have themselves publicly and emphatically avowed that they will not have the question of fault or negligence introduced. It would complicate matters and cost very much more than it would be worth. Besides, it would defeat the entire object of the Act. Wanton, deliberate causing of an accident is of course criminally punishable, on one side as on the other. It will forfeit the workman his allowance. It will make the employer answerable individually according to the provisions of common law, if these should be in excess of what the Insurance Acts exact. To that extent recourse to the Law Courts is retained. And it is now also proposed that accidents incurred in the performance of any directly illegal action or crime shall be excluded from the right to a claim in respect of employers liability. But otherwise fault does not enter into the immediate administration of the Act...
